Latar Belakang : *Beyond Use Date* (BUD) merupakan batas waktu penggunaan obat setelah diracik atau disiapkan atau setelah kemasan primernya dibuka atau rusak. **Tujuan:** Untuk mendapatkan data presentase tingkat pengetahuan masyarakat di RT 01 RW 01 kelurahan Manutapen tentang *Beyond Use Date* (BUD) obat meliputi obat oral sediaan semi padat, sediaan cair, sediaan padat, dan sediaan racikan (puyer) dari dokter. **Metode:** Metode yang digunakan adalah deskriptif kuantitatif. Lokasi penelitian dilakukan di RT 01 RW 01 kelurahan Manutapen Kota Kupang. Teknik pengambilan sampel yang dipilih adalah teknik pengambilan sampel purposive sampling sampel ditetapkan peneliti berdasarkan kriteria. Kriteria yang dimaksud dalam penelitian ini adalah kriteria menurut golongan umur yaitu 15-61 tahun bisa membaca, menulis, dan bersedia mengisi kuisioner. Sampel sebanyak 150 responden. **Hasil penelitian :** yang dilakukan tentang Tingkat Pengetahuan Masyarakat RT 01 RW 01 Kelurahan Manutapen tentang *Beyond Use Date* (BUD) obat non steril tahun 2025 dapat diketahui bahwa dari 60 responden. Hasil penelitian yang dilakukan tentang Tingkat Pengetahuan Masyarakat Rt 01 Rw 01 Kelurahan Manutapen tentang *Beyond Use Date* (BUD) obat non steril tahun 2025 dapat diketahui bahwa dari 60 responden, mayoritas berada pada tingkat pengetahuan kurang sebanyak 39 orang (65,00%), tingkat pengetahuan cukup sebanyak 13 orang (21,67%), dan tingkat pengetahuan baik sebanyak 8 orang (13,33%). Masyarakat memiliki tingkat pengetahuan cukup tentang BUD obat non steril sediaan semipadat (70%), sediaan racikan (61%), sediaan padat (62%), sediaan cair (57%), dan untuk pengetahuan warga tentang BUD (50%). Jadi dengan hasil di atas dapat diketahui masyarakat memiliki tingkat pengetahuan cukup untuk sediaan semipadat, racikan, padat, cair, dan juga pengetahuan warga tentang BUD dengan rata-rata persentase 60%. **Simpulan:** Berdasarkan hasil penelitian ini dapat disimpulkan bahwa pengetahuan masyarakat tentang *Beyond Use Date* (BUD) obat di RT 01 RW 01 Kelurahan Kota Kupang dikategorikan cukup dengan persentase sebesar 60%

Background : *Beyond Use Date* (BUD) is the time limit for use of the drug after it has been formulated or prepared or after the primary packaging has been opened or damaged. **Objective:** To obtain data on the percentage level of knowledge of the community in RT 01 RW 01 Manutapen sub-district regarding *Beyond Use Date* (BUD) medicines including oral medicines in semi-solid preparations, liquid preparations, solid preparations, and mixed preparations (puyer) from doctors. **Method:** The method used is quantitative descriptive. The location of the research was RT 01 RW 01, Manutapen sub-district, Kupang City. The sampling technique chosen was a purposive sampling technique. The sample was determined by the researcher based on criteria. The criteria referred to in this research are criteria according to the age group, namely 15-61 years old who can read, write and are willing to fill out a questionnaire. The sample was 150 respondents. **The results of research :** conducted on the level of knowledge of the community in RT 01 RW 01 Manutapen Village regarding the *Beyond Use Date* (BUD) of non-sterile medicines in 2025 can be seen from 60 respondents. The results of research conducted on the level of knowledge of the community in RT 01 RW 01 Manutapen Village regarding the *Beyond Use Date* (BUD) of non-sterile medicines in 2025 can be seen that of the 60 respondents, the majority were at a level of insufficient knowledge, 39 people (65.00%), with a sufficient level of knowledge of 13. people (21.67%), and a good level of knowledge was 8 people (13.33%). The community has a sufficient level of knowledge about BUD for non-sterile drugs in semisolid preparations (70%), compounded preparations (61%), solid preparations (62%), liquid preparations (57%), and for residents' knowledge about BUD (50%). So with the results above it can be seen that the public has a sufficient level of knowledge regarding semisolid, mixed, solid, liquid preparations, and also the public's knowledge about BUD with an average percentage of 60%. **Conclusion:** Based on the results of this research, it can be concluded that public knowledge about the *Beyond Use Date* (BUD) of drugs in RT 01 RW 01, Kupang City Subdistrict is categorized as sufficient with a percentage of 60%
